40 mg	Pycnogenol® – French maritime pine bark extract (<i>Pinus Pinaster</i>)
100 mg	Rosvita® – Rose Hip (<i>Rosa Canina</i>) extract
400 mg	L-Arginine HCl
400 mg	L-Citrulline

- If you have further questions, please ask your doctor, pharmacist, nurse or other health care provider.
- LADY PRELOX® has been prescribed for you personally and you should not share your medicine with other people. It may harm them, even if their symptoms are the same as yours.
- Read this entire leaflet carefully because it contains important information for you.

1. What is LADY PRELOX® and what it is used for

- LADY PRELOX® is indicated for improving female sexual function and health.
- LADY PRELOX® is an antioxidant that may assist blood circulation, improve libido, orgasm and vaginal lubrication in peri-, pre- and postmenopausal women.
- When taken at the recommended dose, 2 caplets per day of LADY PRELOX® will provide 80 mg French maritime pine bark extract (*Pinus Pinaster*), 200mg Rosvita® – Rose Hip (*Rosa Canina*) extract, 800mg L-Arginine HCl and 800mg L-Citrulline.

Pycnogenol® – French maritime pine bark extract (*Pinus Pinaster*)

- Research into Pycnogenol® for blood flow was the stimulus behind the development of LADY PRELOX®.
- Pycnogenol® is a patented, botanical extract from the bark of the French maritime pine tree and is known for its antioxidant properties.
- It is supported by 40 years of research, including 300 scientific publications, 100 clinical trials and 7,000 study participants.
- Proven to expand and support healthy blood vessels, proven to support and restore production of nitric oxide which encourages better blood flow.

Rosvita® – Rose Hip (*Rosa Canina*) extract

- Rosvita® is a branded, patented rose hip extract that originate from the blossoms/fruit of the wild rose plant.
- An antioxidant, and contains vitamin C, which contributes to normal psychological function and reduction of tiredness and fatigue.
- Researched for gut health properties and increasing blood flow to the limbs.

L-Arginine HCl

- L-Arginine is an amino acid that plays an important role in nitric oxide mechanisms in the body.
- It is an essential precursor for the generation of nitric oxide, a messenger molecule which plays a key role for regulation of blood circulation.
- Nitric oxide is crucial for regulation of blood flow to the genital area and plays a critical role in sex drive and sexual satisfaction.

L-Citrulline

- L-Citrulline is a naturally occurring amino acid. As a precursor of L-Arginine, it has been shown to help open up arteries to improve blood flow and reduce blood pressure.
- Our bodies change L-Citrulline into another amino acid called L-Arginine HCl (mentioned above) and also to nitric oxide.

2. What you need to know before you take LADY PRELOX®

- Do not take LADY PRELOX® if you are hypersensitive (allergic) to any of the ingredients of LADY PRELOX® (listed in section 6).

Warnings and precautions

- If you are on any medication or suffering from any medical condition, it is advisable to seek medical advice before starting any new medicine.
- Nutritional supplements should not be used as a substitute for a varied diet or healthy lifestyle.

Specified warnings:

Consult a relevant health care provider:

- to use if you suffer from a cardiovascular disease and are attempting an increase in physical activity.
- prior to use if you are taking medication for cardiovascular diseases and/or blood thinners
- if your cardiovascular condition worsens.
- prior to use if you have a renal/kidney disease or if you are following a low protein diet.

Children and adolescents

- Not suitable for children.

Other medicines and LADY PRELOX®

- There is no evidence to show any negative interaction with medicines.
- When taking any dietary supplement alongside other medication, it is always advisable to consult your doctor/ pharmacist.

LADY PRELOX® with food and drink

- LADY PRELOX® is not affected by taking it with food or drink.

Pregnancy and breastfeeding

- Safety and effectiveness of LADY PRELOX® during pregnancy and lactation have not been established.
- If you are pregnant or breastfeeding, think you may be pregnant or are planning to have a baby, please consult your doctor, pharmacist or other health care provider for advice before taking this medicine.

Driving and using machines

- LADY PRELOX® should not have any effect on your ability to drive or to use machines.

3. How to take LADY PRELOX®

- It would be a good idea to fill out the FSFI Questionnaire as a self-assessment (Available at: <https://www.mdapp.co/female-sexual-function-index-fsfi-questionnaire-calculator-219/>)
- The usual dose is two (2) caplets per day, preferably with a meal.
- Take LADY PRELOX® once a day, every day, at about the same time each day.
- Taking your medicine at the same time each day will help you remember to take it.
- Do not share medicines prescribed for you with any other person.
- Always take LADY PRELOX® exactly as described in this leaflet or as your doctor, pharmacist or nurse has told you. Check with your health practitioner if you are not sure.

If you take more LADY PRELOX® than you should

- You can experience mild nausea, diarrhoea or gastro-intestinal discomfort if you exceed the dosage.
- In the event of over dosage, consult your doctor or pharmacist.
- If neither is available, contact the nearest hospital or poison control centre.

If you forget to take LADY PRELOX®

- Take a dose as soon as you remember.
- Do not take a double dose to make up for forgotten individual doses.

If you stop taking LADY PRELOX®

- There is no known data available for withdrawal or any other effects when treatment is interrupted or ended early.

4. Possible side effects

- LADY PRELOX® can have side effects.
- No serious side effects or intolerance problems were reported or observed.
- Not all side effects reported for LADY PRELOX® are included in this leaflet.
- Should your general health worsen or if you notice any side effects not mentioned in this leaflet while taking LADY PRELOX®, please inform your doctor or pharmacist.

Contraindication:

- Do not use if you have had a heart attack/myocardial infarction.

Known Adverse Reaction:

- Some people may experience gastrointestinal discomfort (such as diarrhoea).

Reporting of side effects

- If you get side effects, talk to your doctor, pharmacist or nurse.
- You can also report side effects directly to medical@lamelle.co.za

5. How to store LADY PRELOX®

- Store all medicines out of reach of children.
- Store in the original package.
- Store in a cool, dry place below 25 °C.
- Protect from light and moisture.
- Do not store in a bathroom.
- Do not use after the expiry date stated on the label.
- Do not use LADY PRELOX® if you notice visible colour or composition change.
- Return all unused medicine to your pharmacist.
- Do not dispose of unused medicine in drains or sewerage systems.

6. What LADY PRELOX® contains

- The active substances in LADY PRELOX® are Pycnogenol®, French maritime pine bark extract (*Pinus Pinaster*), Rosvita® – Rose Hip (Rosa Canina) extract, L-Arginine HCl and L-Citrulline.
- The other ingredients are Di Calcium Phosphate DC, Microcrystalline Cellulose Avicel PH101, Povidone VA64, CMC, Silicon Dioxide, Magnesium Stearate, Flexicoat Clear PHA1000 (3%) and Flexicoat Blush PHA9085 (6%).

What LADY PRELOX® looks like and contents of the pack

- Light pink-coloured, oval-shaped, scored caplets with a logo imprinted on both sides.
- 15 Caplets are packed into a blister strip made of clear PVC/PVDC film and Alu foil.
- 4 Blister strips are included per outer dark pink cardboard carton, therefore pack contains 60 capsules.

1. Wat is LADY PRELOX® en waarvoor dit gebruik word

- LADY PRELOX® is aangedui vir die bevordering van vroulike seksuele funksie en gesondheid.
- LADY PRELOX® is 'n antioksidant wat bloedsomloop, libido, orgasme en vaginale smering by vroue peri-, pre- en postmenoposaal kan verbeter.
- Wanneer LADY PRELOX® teen die aanbevole dosis van 2 kaplette per dag geneem word, voorsien dit 80 mg maritime pine bark ekstrak (*Pinus Pinaster*), 200 mg Rosvita® – Rose Hip (*Rosa Canina*) ekstrak, 800 mg L-Arginine HCl en 800 mg L-Citrulline.

Pycnogenol® – French maritime pine bark ekstrak (*Pinus Pinaster*)

- Die ondersoek na Pycnogenol® vir bloedvloei was die stimulus vir die ontwikkeling van LADY PRELOX®.
- Pycnogenol® is 'n gepatenteerde, botaniese ekstrak van die bas van die Franse maritime denneboom en is bekend vir antioksidant eienskappe.
- Dit word gerugsteun deur 40 jaar van navorsing, waaronder 300 wetenskaplike publikasies, 100 kliniese proewe en 7 000 deelnemers aan die studies.
- Studies toon dat beter bloedvloei aangemoedig word deur dat Pycnogenol® gesonde bloedvate verwyd, asook die produksie van stikstofoksied herstel en ondersteun.

Rosvita® – Rose Hip (*Rosa Canina*) ekstrak.

- Rosvita® is 'n gepatenteerde rosehip ekstrak handelsmerk wat afkomstig is van die bloeisel/vrugte van die wilde roosplant. Dit is 'n antioksidant en bevat vitamien C, wat bydra tot normale psigiese funksie wat moegheid en uitputting verminder.

L-Arginine HCl

- L-Arginine is 'n aminosuur wat 'n belangrike rol speel in stikstofoksiedmeganismes in die liggaam.
- Dit is 'n noodsaaklike voorloper in die vervaardiging van stikstofoksied, 'n boodskappermolekuul wat 'n sleutelrol speel in die regulering van die bloedsomloop.

L-Citrulline

- As jy die medisyne elke dag op dieselfde tyd neem, sal dit jou help onthou om dit te gebruik.
- Moenie medisyne wat vir jou voorgeskryf is, met iemand anders deel nie.
- Neem LADY PRELOX® altyd presies soos voorgeskryf in hierdie pamflet of soos jou dokter, apteker of verpleegster vir jou voorgeskryf het. Raadpleeg jou dokter as jy nie seker is nie.

As jy meer LADY PRELOX® neem as wat jy behoort te gebruik

- Jy kan effense naarheid, diaree of gastro-intestinale ongemak ervaar as jy die dosis oorskry.
- Raadpleeg jou dokter of apteker in geval van 'n oordosis.
